

CORRIGENDUM

To make EOI more informative and competitive, the Management of Punjab Mandi Board has decided to amend the clauses of EOI for convenience of the bankers.

- 1. Eligibility Criteria**:- Sr. No. 5 of Clause No. 5 regarding Gross NPA and Net NPA further substituted from Gross NPA 5% to 10% and Net NPA 3% to 5%.
- 2. Staff requirement** :- Sr. No. 2 of Clause No 6.7 is read as providing one qualified person every working day for banking/accounting transactions like Bank reconciliation, cash and cheque collection and other point related to banking and accounting as per requirement of market committees etc. The number of working hours of work man may vary according to work load of the respective Market Committee/Mandi Board. The clause 6.7 of criteria for selection is amended as under:-

Sr. No.	Offered by the Bank/Bidder	Marks Earned
1	No man power	0 Marks
2	Qualified Man power in MC's /DMO's/ Xen's according to work load of the respective office well-versed with banking and Accounting operation.	10 Marks

- 3. Number of ATM's** :- Regarding ATM clause No 6.8 if Bank branch /ATM already existing in Mandi yard or within the radius of 500 meter (half km) will be treated as ATM facility to MC's/ DMO/Xen and will be given the weight-age under clause 6.8. Banks shall specifically mention regarding this facility against the name of the Market Committee as per Annexure VI.
- 4. Number of POS /Ticketing Machines**
The requirement of POS and Ticketing Machines will be one in each Market Committee.
- 5. Number of Transactions**
The total number of cash transactions for 153 Market Committees will be 9000 per day approximately.
- 6. Number of Banks**

Mandi board will select three banks on the basis of total points and will allocate the district proportionately on the basis of merit points. The bank with highest point will be allocated the Market Committees of 9 districts comprising Patiala, Sangrur, Barnala, Mansa, Bathinda, Sri Muktsar Sahib, Fazilka, Ferozepur,

Faridkot. The second highest bank will be allocated Market Committees of 7 districts comprising Moga, Ludhiana, F.G.Sahib, Ropar, Mohali, S.B.S. Nagar, Jalandhar, The 3rd bank will be allocated Market Committees of 6 districts comprising Kapurthala, Hoshiarpur, Pathankot, Gurdaspur, Amritsar and Tarn Taran.

7. Regarding Payment Gateway procedure:

The selection of banks for integrated payment mechanism for Engineering Wing and payment gateway for other works including estate will be selected among the 3 qualified banks after examining their services and solutions along with cost/benefit to Punjab Mandi Board.

8. Date Extension

Mandi Board decided to extend the last date of RFP 31-07-2018 to 10-08-2018
